COMMISSION RESOLUTION NO. 26-028
REGARDING LICENSURE OF
CERTAIN OCCUPATIONAL LEVEL I-SW LICENSE
APPLICANTS

WHEREAS, each individual ("Applicant") listed on Exhibit A attached hereto, who is associated with the respective Retail, Mobile, SW Supplier, or Official League Data Provider license holder as set forth on Exhibit A, has applied to the Commission for an Occupational Level I-SW license under Article III, Section 39(g) of the *Missouri Constitution*, Sections 313.800, RSMo, *et seq.*, and 11 CSR 45-20 *et seq.*, as amended from time to time.

RESOLVED, that the license granted to each Applicant as provided herein shall be subject to full and complete compliance with Article III, Section 39(g) of the *Missouri Constitution*, Sections 313.800, RSMo, *et seq.*, and 11 CSR 45-20 *et seq.* and subject to any and all conditions set forth or that may be set forth in Missouri law or regulations or by the Commission, from time to time; and

RESOLVED, that the license granted to each Applicant as provided herein shall be subject to any penalty or to suspension or revocation based on any subsequent investigative findings by the Commission with regard to the Applicant.
