PRELIMINARY ORDER FOR DISCIPLINARY ACTION

Comes now the Missouri Gaming Commission acting in its official capacity pursuant to 11 CSR 45-13.050, and states as follows:

1. The Missouri Gaming Commission (the "Commission" or "MGC") is a state commission created under Chapter 313, RSMo, 2000, with jurisdiction over gaming activities, including riverboat gambling activities, in the State of Missouri.
2. The Commission issued Pinnacle Entertainment, Inc., a Class A gaming license to develop and operate Class B gaming licenses in the State of Missouri.
3. Pinnacle Entertainment, Inc., is the parent organization or controlling entity of Casino One Corporation.
4. The Commission issued a Class B riverboat gambling license to Casino One Corporation ("Company"), to conduct games on and operate the excursion gambling boat known as Lumiere Place Casino ("Casino").
5. As the holder of a Class B license, the Company is subject to the provisions of §§ 313.800 to 313.850, RSMo 2000, and the regulations promulgated thereunder by the Commission.

STATEMENT OF FACTS¹

6. On January 20, 2013, at approximately 4:44 p.m., an underage female patron and another female accompanying her entered the Casino's Stadium Bar and Grill and were served two shots of an alcoholic beverage by bartender Laura Oram. Ms. Oram failed to request identification from either person. The two females left the bar at 5:14 p.m.
7. At approximately 6:35 p.m., the underage female patron attempted to gain entry to the Casino floor by presenting a false identification.
8. Security Shift Supervisor Charles Coats and Security Officer Marcus Fulton approached the underage female patron and asked to see her identification as she entered the Casino. The underage patron provided them with false identification.

9. At approximately 6:39 p.m., the underage female patron was escorted from the gaming floor to the MGC office after it was determined that her identification was false.

LAW

10. Under § 313.805(6), RSMo 2000, the Commission may assess any appropriate administrative penalty against a licensee, including but not limited to, suspension, revocation or penalties of an amount determined by the Commission.
11. Section 313.812.14, RSMo, states, in pertinent part, as follows:

A holder of any license shall be subject to imposition of penalties, suspension or revocation of such license, or if the person is an applicant for licensure, the denial of the application, for any act or failure to act by himself or his agents or employees, that is injurious to the public health, safety, morals, good order and general welfare of the people of the state of Missouri, or that would discredit or tend to discredit the Missouri gaming industry or the state of Missouri unless the licensee proves by clear and convincing evidence that it is not guilty of such action. The commission shall take appropriate action against any licensee who violates the law or the rules and regulations of the commission. Without limiting other provisions of this subsection, the following acts or omissions may be grounds for such discipline.

- (1) Failing to comply with or make provision for compliance with sections 313.800 to 313.850, the rules and regulations of the commission or any federal, state or local law or regulations;
- (2) Failing to comply with any rule, order or ruling of the commission or its agents pertaining to gaming[.]

12. Title 11 CSR 45-12.090(3) states, in pertinent part, as follows:

.... An excursion liquor licensee shall not, through actions of his/her own or of an employee, sell, vend, give away its or otherwise supply any intoxicating liquor in any quantity whatsoever to any person under the age of twenty-one (21) years A licensee shall not permit any person under the age of twenty-one (21) years ... to consume intoxicating liquor on the licensed premises.

VIOLATIONS

13. The actions or omissions of employees or agents of the Company as described above constitute the failure to identify and verify the age of an underage patron and the supplying of an intoxicating liquor to a person under the age of twenty-one (21) years, thereby violating 11 CSR 45-12.090(3).
14. The Company is therefore subject to discipline for such violations pursuant to §§ 313.805(6) and 313.812.14(1) and (2), RSMo.

PENALTY PROPOSED

15. Under § 313.805(6), RSMo 2000, the Commission has the power to assess any appropriate administrative penalty against the Company, as the holder of a Class B license.
16. THEREFORE, it is proposed that the Commission fine Casino One Corporation the amount of \$5,000 for the violations set forth herein.
