KEY PERSON LICENSEES

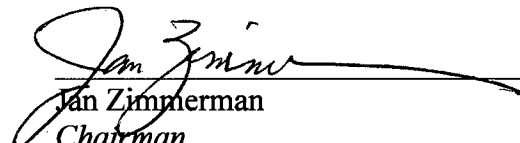

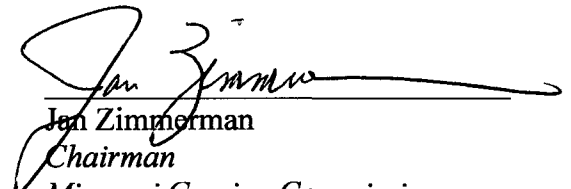
